RESIDENTS IN PERMANENT HOUSING PROGRAM TYPICALLY LIVE AT ST. JOSEPH'S FOR MORE THAN 24 MONTHS. ST. JOSEPH'S FOOD PROGRAM IS AN IMPORTANT PART OF THE SERVICES PROVIDED FOR RESIDENTS. ST. JOSEPH'S PREPARES AND SERVES MEALS AT THE SAME TIME EVERYDAY, PROVIDING A DAILY STRUCTURE THAT IS OFTEN LACKING IN THE RESIDENTS' PREVIOUS LIFESTYLE.
