Crib for Kids was founded to provide support to the families whose infants died of SIDS or other Sleep-Related Deaths, educate the general public and health professionals about these types of deaths, and promote and support research into their cause and prevention. Since the inception of the Crib for Kids Campaign in 1998, the goal has been to educate parents and care givers about reducing the risk of these deaths by placing babies on their backs to sleep on a firm mattress in a safety approved crib, and to provide cribs and other safe sleep items to families in need

 Safe Sleep Ambassador Outreach Program - This program formally educates participants including social workers, caseworkers, nurses, students and others from diverse backgrounds to take the infant safe sleep message to their friends, family and communities based on the premise "Each one, teach one", and to teach at least three other persons about safe sleep. This program encourages participants to consider the infant safe sleep message as part of their personal as well as professional lives to share this life-saving information. Over 950 persons were trained as safe sleep ambassadors and received certificates and buttons to show their commitment to teach others. Family Support - Bereavement support, information and referral service to families and friends affected by the death of an infant. Grief support meetings are held monthly at Crib for Kids office. Additional grief support provided to families experiencing infant deaths through phone calls, mailed materials and home visits

Approximately 5,300 professionals and individuals in the general public were educated through formal presentations, health fairs and community events.
