THE STUDENTS AND THEIR MENTORS PARTICIPATE IN A BBBS PLANNED CURRICULUM SPECIFICALLY DESIGNED TO GIVE EXPOSURE TO THE WORKPLACE AND PROVIDE OPPORTUNITIES FOR CAREER AND EDUCATIONAL GOAL SETTING.D. BE A MIDDLE SCHOOL MENTOR - A CAREER BASED MENTORING PROGRAM WITH ADULTS FROM MULTIPLE PROFESSIONS AS MENTORS. ONCE PER MONTH, THE MENTEES AND MENTORS MEET AT THE SCHOOL FOR AN IN-PERSON "PAIR EVENT" FOR AN OPPORTUNITY FOR PAIRS TO INTERACT, DEVELOP THEIR RELATIONSHIPS, AND APPLY THE CURRICULUM TO REAL-LIFE SCENARIOS. THE MENTEES AND MENTORS CONTINUE TO WORK TOGETHER, IN-PERSON AND ONLINE, THROUGH HIGH SCHOOL GRADUATION.
