Sports Outreach - This program provides opportunities for children, youth, adults and military veterans who are blind and visually impaired to become introduced to sport and physical activity. Participants participate in a variety of sports including goalball, judo, beep baseball, beep kickball, power-lifting, track and field, tandem cycling, swimming, skiing, dragon boating, kayaking, paddle boarding, hiking, and more. The organization operated more than 90 Sports Outreach Program experiences during the fiscal year to improve the quality of life for nearly 1,000 people with visual impairments. Most of the nearly 56,000 school-age children who are blind have never experienced any type of physical activity, this program is critical because it helps participants build confidence, enhance self-esteem, develop long-lasting friendships, improve their physical and muscular strength, and empowers them to excel in all areas of life.

Form 990, Part III, Line 4b:

Sports Teams Program/Sports Adaptations - The Sports Teams Program provides children, youth, adults and military veterans who are blind and visually impaired with the opportunity to participate in sports and physical activity on an on-going basis through one of our on-going sports teams. During the fiscal year, the program provided youth programming throughout the State of Oregon and adult programming in Clark County, WA/Portland, OR, and Boise, ID. In FY17-18, 88 individuals who are blind or visually impaired were served through the Sports Team Program and 1,506 program service hours were delivered. This program helps to combat the 70% nationwide unemployment rate among adults with visual impairments by building confidence, enhancing self-esteem and instilling the tools they need to be successful in all areas of life including school and employment. The Sports Adaptation Program provides adaptations to blind and visually impaired students, adults, family members, teachers, and community organizations about how to adapt sports for individuals who are blind and visually impaired. This program impacted 425 individuals and provided 186 hours of direct program services in the year ending June 30th, 2018.

Increasing Visibility (Public Awareness Program) The Associations public awareness program provides community members the opportunity to learn more about the abilities of people who are blind and visually impaired. This program is delivered through public awareness campaigns, speaking engagements, and allowing community members to experience blindness and participate with athletes. In FY17-18, more than 20,000 contacts were made with community members across Washington, Oregon, Idaho and Montana.

A person has a financial interest if the person has, directly or indirectly, through business, investment, or family, an ownership or investment interest in any entity with which NWABA has a transaction or arrangement, a compensation arrangement with NWABA or with any entity or individual with which NWABA has a transaction or arrangement, or a potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which NWABA is negotiating a transaction or arrangement. Interested persons have the duty to disclose any actual or possible conflict of interest to the Board or Executive Committee. After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the Board or Executive Committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining Board or Executive Committee members shall decide if a conflict of interest exists. After exercising due diligence, the Board or Executive Committee shall determine whether NWABA can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest. If a more advantageous transaction or arrangement is not reasonable possible under circumstances not producing a conflict of interest, the Board or Executive Committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in NWABA's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination, it shall make its decision as to whether to enter into the transaction or arrangement. The interested person may recuse himself or herself at any time from involvement in any decision or discussion in which the director believes he or she has or may have a conflict of interest, without going through the process for determining whether a conflict of interest exists.</p>
