In 2017, The Food Basket's Emergency Food program served the neediest residents throughout the 9 districts of Hawai'i Island through over 100 partner agencies. Emergency food was also distributed directly through our Ohana (family) food drops, Keiki (children) backpacks, Kupuna (senior) Pantry and Senior Brown Bag programs. On average over 13,700 unduplicated individuals were served per month with over 1.6 million pounds of food distributed island-wide. The Food Basket continued its Supplemental Nutrition Assistance Program (SNAP - formerly known as food stamps) Outreach services that made over 3,000 client contacts and enrolled over 100 eligible clients for SNAP benefits.

Our Community Supported Agriculture (CSA) program DA BOX continued to incentivize healthy eating by distributing produce to SNAP recipients at a discount. The program operates year-round with weekly distributions of Hawai'i Island grown produce purchased from over 30 local farms. In addition, The Food Basket was awarded a three-year USDA Food Insecurity Nutrition Incentive (FINI) grant of \$500,000 for DA BUX Double Up Food Bucks program to provide a 50% discount on Hawai'i Island grown produce at select grocers for SNAP beneficiaries.
