On a case by case basis, Cottages of Hope provides one on one financial and job coaching and education sessions intended to help clients learn to create budgets, create plans to reduce debt, to improve credit scores, to improve resumes, and to increase the quality of their interview skills. Cottages of Hope is a SparkPoint Center where hard-working, low-income people can access a full range of services to help them get out of poverty and achieve long-term financial stability. The Center brings together the most effective nonprofit and government partners to help clients build assets, grow income, and manage debt. Each client works with a personal coach, who helps create a step-by-step plan to accomplish financial goals. This long-term approach provides on-going support until goals are accomplished.
