"CASA" is an acronym for Court Appointed Special Advocate. The only costs of the program are the salaries of the program director and staff and the cost of training the CASA's. For each staff member we can increase the number of CASA's which, in turn, increases the number of children served in the community. In 2021, the program advocated for 179 children, 64 of which were new to the program. The children served were from three Kentucky counties: 86 from Kenton Co., 71 from Campbell Co., and 22 from Pendleton Co. There were 59 CASA volunteers, of which, 11 were new in 2021. Volunteers served a total of 4,171 hours of advocacy services in 2021. Across the three counties, there were 1,539 children in the judicial system as a result of dependency, abuse, & neglect. Our agency advocated for 11.6% of the total children in the system, so the need for additional volunteers is critical.
