SNACKCHEF SERVED 5 LOCAL AFTER SCHOOL CENTERS WEEKLY FOR A TOTAL OF 97 SNACKCHEF SESSIONS THROUGH THE FIRST WEEK OF MARCH. WE WORKED WITH 190 CHILDREN PER MONTH AND PROVIDED A TOTAL OF 7,047 SNACKS. IN RESPONSE TO COVID-19, ALL NUTRITION LESSONS WERE SENT HOME IN OUR BAGS OF FOOD. OUR NUTRITION EDUCATION PROGRAMMING AIMS TO ENCOURAGE CHILDREN TO TRY NUTRITIOUS FOODS, EXERCISE, AND GET INVOLVED IN FOOD PREPARATION SO THAT THEY EXPERIENCE THE BENEFITS OF A DIET COMPOSED OF A VARIETY OF HEALTHY FOODS.
