The Little Strides curriculum uses games and activities that focus on developing vital gross motor skills that students need upon entering elementary school.

Each season, participants are provided appropriate running shoes during practices while they train for a race hosted inside the facility. Chicago Run trains JTDC Recreational staff in trauma informing coaching techniques to help facilitate practices.
