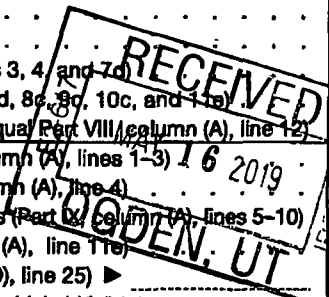

Communities in Schools of Spokane County provided basic needs to more than 8,200 students in three high schools, four middle schools, and 25 elementary schools in Airway Heights, Cheney, Medical Lake, Spokane and Spokane Valley. Basic needs include food, clothing, and school supplies. Site Coordinators identify children who are the most at-risk of academic failure, set an academic goal, with each child to develop a plan to keep the identified child from failing. The Site Coordinators broker internal and external services throughout the year, checks and documents each child's progress, and advocates for the child and their family. Mentors are provided to more than 300 children during the year at 32 public schools.
