Unite and empower Native American Communities in Michigan with the common goal of ending Domestic Violence and Sexual Assault.

Staff provided training and technical assistance to Tribes as requested. Staff reduction took place for the months of September and October.

An election of members of the Board of Directors occurred in August 2014, with four current board members maintaining their seat and two new board members being elected. Towards the end of the year there were additional changes to the board as one resigned.

Part VI 6 Coalition has members

7a An election of board members is held. Those eligible to vote are paying members of the coalition.

8b There was one committee for the evaluation and compensation of the executive director.

11b The 990 forms are given to the board to review. The document is then discussed and signed by a board member that is available.

19 All documents required to be made available to the public are held in the office of the coalition and are available for review upon request. The request does not have to be written. The Executive Director has access to the required documents and can easily produce them as needed.

Part XI

9 the credit is an adjustment for revenue received in 2014 covering 2013 loss, as well as some funds drawn down at the very end of 2014 to cover 2015 expenses.

The 990 for 2014 is being amended by recommendation of our Auditors to correct the fiscal year. The organization was established with a tax year of October 1 to September 30th and initially the 1st tax preparer did the taxes on a calendar year and the accountant followed each consecutive year. In January 2016 during a 1st audit this was discovered as being filed incorrectly.
