Blissings in a Backpack is a 501 (c)(3) non-profit organization that is feeding approximately 87,300 children in approximately 1,092 schools as of June 30, 2019. The program is a hybrid of private sector funding and public partnership carried out in public schools. This unique program is designed to feed elementary school children whose families qualify for the federal free or reduced meal program, and may not have any or enough food on the weekends. For 38 weeks during the school year on Friday, students receive their backpacks with staples that require little to no preparation.
