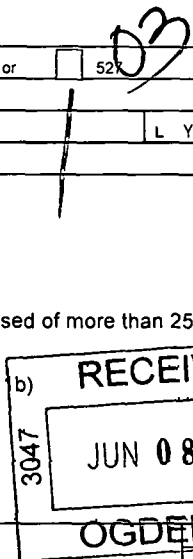

Currently, Kate's Kart, Inc. has over 290 volunteers collecting, counting, sorting, labeling, stocking and distributing more than 4,000 books per month to 20 area hospitals and several pediatric offices. During 2019, Kate's Kart distributed 45,607 books to 30 karts in 20 area hospitals.
