**Passport Program: The Passport to College program provides at-risk, inner-city youth (those who are economically disadvantaged, teen parents or foster youth) and adults who have dropped out of high schools, with an opportunity to earn their high school equivalency and prepare for college and careers simultaneously. Students are provided with free, enriched preparation for their exams, including college test preparation and comprehensive college supports and workforce training services, in addition to wraparound social services. In 2016, 632 students were placed on a path to self-sufficiency.**

4b (Code: ) (Expenses \$ **30,000** including grants of \$ --) (Revenue \$ **0**)  
**Compass Program: The Compass program provides GED graduates and first generation college students with ongoing support and guidance as they complete their 2 and 4 year degrees at a local college. These students have access to a personal mentor dedicated to their success, in addition to a designated area, located next to the college campus, staffed with tutors and equipped with laptops and textbooks. In 2016, 30 students were supported as they persisted toward graduation.**

**Fast Pass Program: The Fast Pass program offers low-income high school students with free standardized test preparation workshops to prepare them for dual credit courses and college enrollment. In 2016, Fast Pass provided 50 workshops and served 1,974 students.**
