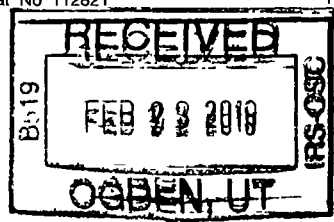

Economic Development Broad Community Connections continued its development of the ReFresh Project, culminating in the opening of the project. BCC continued to convene the ReFresh Coalition, a group of over 40 community partners, to develop collective impact programming that holistically addresses the social and environmental determinants of health in the Broad Street communities. The ReFresh Project will be a catalytic economic development project for the Broad Street commercial corridor, and promote the health of the surrounding communities. Broad Community Connections also continued its work with business and property owners, and convened the Broad Street and Bayou Road Merchants Association

Design and Planning Broad Community Connections implemented the 100 Trees for Broad and Bayou Road project, planting trees and beautifying the streetscape in the Broad and Bayou Road commercial district. BCC continued to work with public and private partners to advocate for and implement several streetscape enhancement projects, including a road diet and bicycle lane on Broad Street, as well as projects along the Lafitte Greenway, Broad Street, and Bayou Road. Broad Community Connections also provides zoning and technical assistance to business and property owners, community and neighborhood organizations, and other partners and stakeholders, including working extensively with stakeholders on the Comprehensive Zoning Ordinance
