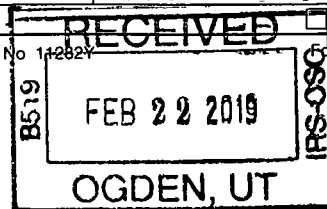

Community and Economic Development: Broad Community Connections continues to work to make Broad Street one of the most vibrant, equitable, and diverse commercial corridors in New Orleans. BCC continues to lead the ReFresh Project, including convening the ReFresh Coalition, growing it to over 60 organizations, and hiring the first ReFresh Coordinator to oversee the development of collaborative programming at the ReFresh Project. The Coordinator began a strategic planning process among ReFresh Project partners and community leaders focused on health equity, and initiated several community-driven efforts to cultivate community leadership, including a mural project. The ReFresh Project has proven to be a catalytic economic development project for the Broad Street commercial corridor. Broad Community Connections continues its work to organize and support Broad Street and Bayou Road business and property owners, including convening business association meetings and providing technical assistance for a public facade improvement program. Broad Community Connections has begun working on two additional anchor real estate and community economic development projects through the Broad and Bayou Road commercial district.

Policy, Design, and Planning: Broad Community Connections has continued to lead and support efforts to promote quality of life in the Broad Street communities, working with community members, business and property owners, partner organizations, and other stakeholders on issues such as zoning, development, beautification, and public safety. BCC, in partnership with organizations such as the City of New Orleans and the Arts Council of New Orleans, has led public art initiatives, successfully secured the creation of bicycle lanes in the corridor, co-sponsored a complete streets visioning plan for the Broad Street commercial corridor, and provided technical assistance on planning and zoning matters. Broad Community Connections has also begun a commercial corridor revitalization program that will incorporate lessons learned on Broad Street, as well as national best practices in order to promote an urban commercial corridor-based revitalization strategy throughout the City of New Orleans.

In order to finance and develop the ReFresh Project, a New Markets Tax Credit-financed "Community Health Hub" project, Broad Community Connections created two subsidiary entities, both of which are wholly-owned, single member subsidiary LLCs and are treated as disregarded entities. BCC Refresh LLC and BCC Leverage Lender LLC. BCC Refresh LLC is a 20% owner in the joint venture LLC that co-owns the ReFresh Project, Refresh New Orleans LLC. BCC Leverage Lender LLC performed the junior leverage lender functions for the New Markets Tax Credit transaction. In 2015, Refresh New Orleans LLC had total assets of \$16,807,326 and total liabilities of \$18,113,804, resulting in a members' deficit of (\$1,306,478). Because BCC Refresh LLC has a 20% ownership of the entity, the net assets of BCC Refresh LLC are (\$261,296). In 2015, BCC Leverage Lender LLC had total assets of \$7,996,025, and total liabilities of \$7,622,088, resulting in member's equity of \$373,937.
