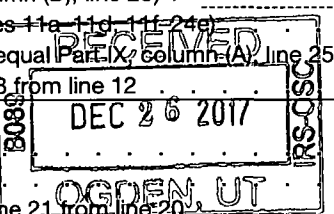

Savings Accounts - A major objective of the credit union is to provide our members with a safe place to keep their money and earn interest at the same time. PCU also encourage its members, especially the younger ones, to develop consistent saving habits. To this end, the credit union has cooperated with several agencies to provide incentives for its members to save. At the end of 2016, the credit union has 3,119 saving accounts with approximately \$2.184 million in deposit and 41 Share Certificate accounts, of which 37 accounts are from members totaling approximately \$172K, and 4 accounts are from non-members totaling approximately \$860K

Checking Accounts are offered mainly for the convenience of our members in meeting their financial needs. To extent the functionality of these accounts, we provide members with free ATM cards, internet account access, bill paying services, and electronic statements. At the end of 2016, we have 471 checking accounts totaling about \$279,500

Loans - Promise Credit Union offers a variety of consumer loan products to its members, including auto loans, title loans, small equipment loans, citizenship loans (for immigrants applying for US citizenship), Preferred Associate Loans (PAL) and PAL Plus. The PAL Plus loan has a saving feature that is part of the repayment plan and is used mostly to build up a member's credit history. We also offer credit life and Disability Insurance and Guaranteed Auto Protection (GAP) to our members

For logistical purpose, the President and the 4 staff of Promise Credit Union ("PCU") are employees of the sponsoring organization,

BakerRipley. Therefore they are compensated by BakerRipley and their W2 (and W3) are reported under BakerRipley's EIN. The credit

union reimbursed BakerRipley for all payroll and benefits costs. This is the reason why Form 990 Part V line 2 a shows a 0 value as

PCU did not file the W3 Transmittal of Wages and Tax Statements and W2s

This administrative arrangement enables Promise Credit Union to carry out its mission without assuming the administrative functions

of HR and Payroll. The staff, however, are accountable to the Board of Promise Credit Union, which sets the course for the organization.

2.) Form 990 - Part IV line 12a

Under CFR 12 Part 715 of NCUA Rules and Regulations, Promise Credit Union is not required to obtain separate independent audited

financial statements due to having assets that are less than \$500 million. Pursuant to this regulation, PCU has engaged the services of

an independent party, Credit Union Resources, Inc., to conduct a Supervisory Committee Annual review of its books and records.

The review was performed in accordance with the requirements of Title 7, Part 6, Section 91.507 of the Texas Administrative Code and

Section 715.7(c) of the NCUA Rules and Regulations, and included additional procedures as deemed necessary.

3.) Form 990 - Part V line 1a-1c

The credit union's invoices are processed and paid by BakerRipley. Therefore, all applicable IRS filings and compliance matters,

including Form 1096, are filed by BakerRipley.

4.) Form 990 - Part V line 2a

As stated in (1) above, all Promise Credit Union's staff were on BakerRipley's payroll, which also issued the W-3 and W-2 at year-end

for these staff under BakerRipley's EIN.

5.) Form 990 - Part VI line 3

In October 2016, Promise Credit Union's President/CEO, Randy Martinez, resigned from his position. To fill the vacancy, the Board has

engaged the services of an independent consultant, Dr. Paul Withey, to assume the functions of an Interim CEO. All credit union activities,

however, are still being reported and accounted to the Board at its monthly meetings.

Promise Credit Union's Record Management Program provides the framework and delineates the steps by which record retention and destruction are to be followed.

Salary surveys of similar sized credit unions are compared in determining compensation, along with any other information that are available through consultation and published sources. Also, expectation of the duties and performance of the President/CEO are also of consideration. The Board performs an annual performance evaluation of the President/CEO and approves the compensation.
