THE BOYS AND GIRLS CLUBS OF MOULTRIE/COLQUITT COUNTY, INC.(THE "CLUB") IS A COMMUNITY-BASED ORGANIZATION THAT PROVIDES YOUNG PEOPLE WITH A SAFE AND FUN PLACE TO LEARN AND GROW. THE CLUB OFFERS PROGRAMS AND SERVICES DESIGNED TO BUILD CHARACTER AND STRENGTHEN LIFE SKILLS. THE CLUB OPENED AN ADDITIONAL SITE AUGUST 8, 2019,WHICH BRINGS THE TOTAL TO THREE OPERATING SITES. THE CLUB'S TOTAL MEMBERSHIP WAS 653 WHICH WAS AN INCREASE OF 8.65% FROM 2018. IN ADDITION TO THE MEMBERSHIP INCREASE, THE CLUB HAD AN INCREASE OF 21% IN OUTREACH SERVICES. THE CLUB PROVIDED MORE THAN 135,000 MEALS TO ITS MEMBERS AND THE COMMUNITY AT NO CHARGE TO ITS RECIPIENTS.
