In eastern North Carolina (Hurricane Florence) we continued our rebuilding program in Craven and Pamlico Counties completing 46 fully restored homes. We also established a rebuilding operation in Panama City, FL (Hurricane Michael), with seven homes underway. As a volunteer driven organization, COVID-19 had a dramatic effect driving our volunteer count to zero. In March we essentially transitioned to building with only staff and subcontractors.
