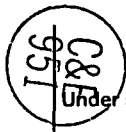

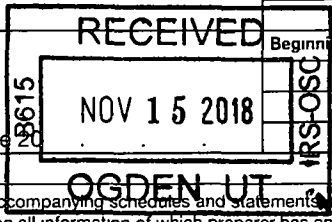

The foster care training and supervision program continued in 2017. During that time 60 people attended orientation programs, 53 people completed their foster parent training, and 30 families provided 7770 bed nights for foster children in the foster care supervision program with Mending Hearts Family Services. 2 adoptions were also finalized.
