Member ActivitiesOur 5th Annual Housing Expo provided housing information and resources to support low and moderate income renters, first time buyers and home owners in San Francisco. This event was attended by 1055 people. The main hall featured over 50 exhibitors, including local nonprofits, government agencies and industry experts. The Counseling and Assistance Room offered individual counseling sessions and face to face meetings with participating loan servicers. This event also offered 12 free workshops on housing related topics and City housing assistance programs, and affordable rentals and 3 different bus tours where participants could view affordable housing for sale. Homeownership SF hosted peer sharing sessions to discuss best practices for housing counseling, facilitated scholarships for our Member Agency counseling staff to attend National training courses and hosted a 2 day training on counseling people on student loans, presented by Neighborworks America. As the lead agency in a collaborative grant including all 5 of our Member Agencies, we expanded our foreclosure prevention services to include non-default related services. By supporting home owners with counseling and workshops on topics that support home maintenance and long term planning, we help homeowners avoid delinquency through good financial management. Additionally, we continue to provide outreach, information and individual counseling to homeowners who have fallen behind on their home mortgage payments. In addition, Homeownership SF operates as the lead fiscal agent for the members, a group of partner nonprofit agencies. Pass through activities related to this work were \$436,156 for the year ended June 30, 2017.

Form 990, Part III, Line 4b:

Homebuyer Education and ResourcesThis year Homeownership SF increased its number of website visitors by 14.5%. The HSF website is a one stop resource for first time homebuyer resources and homeownership assistance in San Francisco. We provide a coordinated calendar of workshops for our five member counseling agencies, in addition to affordable property information, including Below Market Rate (BMR) property listings and ownership housing cooperative units for sale. The website also features housing related news, program updates, and foreclosure prevention information, and provides direct links to our HSF member agencies and other affordable housing providers in San Francisco.

Form 990, Part III, Line 4c:

Advocacy and Public Policy Homeownership SF established our Policy Advocacy Committee in 2014. This year our committee continued to advise our organization on strategies to increase access to housing and affordable housing production for low to moderate income residents. Homeownership SF staff provided data and input to San Francisco Board of Supervisors during their process to revise City inclusionary housing requirements and income limits, increasing the number of Below Market Rate units required in new construction projects. Additionally, Homeownership SF created educational materials for our member organizations and other housing service providers regarding state and local housing measures, and participated in monthly meetings with the Community Council of Housing Organizations.
