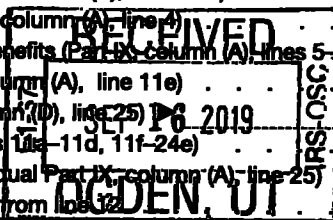

The Clinic offers primary medical care, preventative care, specialty care, laboratory services, prescription assistance and referrals to community social services. Dental services including consultations, extractions, and restorative care are also provided. The Clinic operates with over 173 volunteer medical professionals and support staff whose value is over \$555,272. Over 6,735 patient visits were provided in 2018. There were over 2,066 prescriptions filled in 2018 with a value of \$2,956,572
