Total contributions on Schedule A, Part II, Section A, Line 1 of \$13,000 differs from contributions reported on Part I, Line 8, of \$430,500. The difference of \$417,500 is the aggregate of three unusual grants received for equity funding of our next project, Fistera Gardens Townhomes. The grants were \$250,000 from The DLW Foundation, \$147,500 from The Collins Foundation, and \$20,000 from Steve and Theresa Johnson. We have the following additional equity funding commitments for Fistera Gardens Townhomes: (1) Meyer Memorial Trust, \$250,000; Lincoln County Economic Development, \$10,000; (3) The DLW Foundation, \$325,000; (4) The Norton Foundation \$250,000; (5) several other individuals and companies, \$187,500; and (7) \$2,072,862 in low income housing tax credit equity from Alliant Capital Ltd. We have loan commitments from Washington Federal for \$3,075,000 in construction loan and \$850,000 in permanent loan; and from Oregon Housing and Community Services Department, of \$797,979 in permanent loan. We expect to begin construction of Fistera Gardens Townhomes in the second quarter of 2018.
