Our Coastal Village, Inc. developed a 7-unit affordable workforce housing project in Yachats, Oregon at a cost of about \$1.5 million. The planning for that project began in 2009 and zoning changes were required that took nearly two years. Then the design and planning phases took another year; followed by a year of construction. The project was leased to qualifying tenants for five years before we were able to qualify our first tenant for a loan to purchase the townhouse he was renting. Since then we have sold two additional units, also on a permanently affordable basis, to two additional persons. Throughout that five year period Mr. Morrill took no compensation for services rendered. A typical development fee is about 15% of a project's cost which in this case would be about \$225,000. The Board has approved a \$100,000 development fee on this project. The \$27,000 paid in 2010 was the first installment toward that \$100,000. The balance will be paid over the next several years.
