Our Coastal Village, Inc. developed a 7-unit affordable housing project in Yachats, Oregon at a cost of about \$1.5 million. The planning for that project began in 2009 and zoning changes were required that took nearly two years. Then the design and planning phases took another year; followed by a year of construction. The project was leased to qualifying tenants for five years before we were able to qualify our first tenant for a loan to purchase the townhouse he was renting. Since then we have sold two additional units, also on a permanently affordable basis, to two additional persons. Throughout that five-year period Mr. Morrill took no compensation for services rendered. A typical development fee is about 15% of a project's cost which in this case would be about \$225,000. The Board has approved a \$100,000 development fee for this project. In 2018, the first \$27,000 was paid; and in 2019 another \$27,000 was paid, for a total of \$54,000, leaving \$46,000 for payment in later years.

Our Coastal Village, Inc. developed a 21-unit affordable workforce housing project in Yachats, Oregon, which is owned by Fistera Gardens Townhomes Limited Partnership, of which Our Coastal Village, Inc. is the General Partner. On this Project Our Coastal Village, Inc. is allowed a development fee of \$650,000 payable over time. In 2018 and 2019 Our Coastal Village, Inc. received toward this development fee a total of \$239,000. The Board has authorized payment to Mr. Morrill over time a development fee equal to \$325,000 or 50% of the total development fee earned by Our Coastal Village, Inc. In 2019, Our Coastal Village, Inc. paid Mr. Morrill \$59,750 toward this \$325,000 development fee. The remainder of \$265,250 will be paid to Mr. Morrill over time as Our Coastal Village, Inc. receives its development fee.
