COMPLETELY REHABILITATED AND MODERNIZED A VACANT, BLIGHTED HOUSE, COMPLETED SIX RESIDENTIAL FADE IMPROVEMENT PROJECTS, ACQUIRED A SECOND HOUSE TO BE REHABILITATED NEXT YEAR. 
