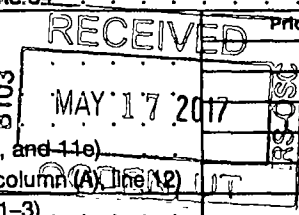

At Truth Spring Academy, enrollment from our community more than doubled this year. All children in the school are Title 7. Over 24 students attended on a full time basis. Resources have been used to hire educated and experienced teachers. Students have strong measurable adaptive and academic growth based on nationally standardized exams. In addition to working with students, we have provided families and neighbors the opportunity to be part of our enrichment program and to volunteer in ways that cultivate a stronger sense of community.

Acquired and renovated 2 homes in community. Placed 2 families in renovated homes with rents of \$300 or \$350 per month. Families are addressing their individual needs as part of program to help them get out and stay out of poverty. In addition, the community developed as a result of renovated homes which were previously on demolition list and provided jobs for some community members who were employed working on the homes.
