Play Back Memphis and the Memphis Police Department continue to work on the relationships and therapeutic counseling. Institue, which is the core of our program (group therapy sessions) have become a better place for ex offenders to share, develop life plans and gain insight on issues. Traumas are being turned around as opportunities to grow.
