All residents were served by case managers who assisted the residents with goal setting, problem solving and connecting with area resources in order to become self sufficient upon completion of the 90 day program. Also, during their stay at the Shelter, residents were counseled in the areas of personal care, family living, financial responsibility, job interviewing and employment. Seventy-two (72) percent of Shelter residents left the program having both employment and housing.
