Student Advocacy Services by working with parents and the Omaha School District to assist in providing quality education enhancement to students to improve academic achievement and learning skills. The program includes tutoring, academic coaching and counseling, report card evaluation, classroom observations and parent consultations.

Student Advocacy Services/Summer Youth Program: Support students K - High School by providing tutorial assessments, in class room observations and development of individualized education plans for students in conjunction with the Omaha School District. The Student Advocacy Services is year round to ensure long-term academic success of the students. Students who consistently participate in the program move at least 1/2 grade or more. Services include consultations with student-parent sessions, classroom observations, report card evaluations and academic, social and behavior coaching and counseling.

During the summer, the students participate in math, writing and language art skills. The program also builds strong academic skills in reading and reading comprehension, foreign language, science, nutrition and life skills. The students also participate in the free breakfast and lunch program during the summer. At the end of the summer, the program provides each student with backpacks which are filled with school supplies. Most of the services are provided to the students at no-cost or a minimal fee.

Life Advancement program: This partnership involves job preparation, skills training, provides counseling, building resumes, provide interview coaching for potential job openings. The program co-partners with local health care and medical professionals and annually hosts a health care fair.

PDAC is located in the heart of the Omaha community most impacted with poverty/low income families. However, the program services are available to the entire Omaha community. PDAC partners with the Omaha and the Native American Indian Reservation with its spring and fall clothing give-away program.

Part VIII Statement of Revenue (Line 1g): The non-cash donations (\$143,259) include \$3,9,14.00 for Clothing and household goods as well as

\$46,800.00 for the in-kind-donations from Joy of Life Faith Ministries, Inc. The Purpose Driven Advocacy Center, Inc. is housed and operates

out of the space provided by Joy of Life Ministries, Inc. This in-kind donation included facility, equipment and utility costs. Moreover, the non-

cash donations included 500 shares of Union Pacific Stock with a FMV of \$92,545.00

Part VIII Statement of Revenue (Line 2a): Program Fees, (\$5,586). The students participating in the PDAC program pay only a nominal fee or

receive fee waivers; thus our kind donor support carries the major costs of the program. PDAC is located in the low-income area of Omaha, NE

and most clients are unable to pay the full cost of the services provided.
