Paper files were dumped and scattered. Related, our administrative assistant quit without warning on November 7 as a result of an assault on her person that may have been related to the break in. Records had to be found, entered and reconciled, as it was learned that it was not done as expected by the administrative hire. APEX had only our Executive Director, who experienced multiple health issues from July of 2017 through April of 2017, leaving limited availability to run the program, find and reconcile data, and go to numerous doctor appointments and tests. APEX had no funds to hire additional help. As funding improved and our E.D. was complete with testing and therapies, we were able to reconcile accounts and complete our 990. We realize that not having time is not reasonable cause. We are asking for a reduced penalty, factoring the theft, vandalism, and cumulative time missed. We are hiring a part-time financial secretary going forward and have a new system of cloud backup not just of software, but of hard files to be scanned in case of another vandalism.
