Explanation: APEX was granted an extension for our 2016 filing to November 15, 2017. On November 3, 2017 our offices were broken in to and vandalized as well as a computer stolen that had numerous records. Paper files were dumped and scattered. Related, our administrative assistant quit without warning on November 7, 2017 as a result of an assault on her person that may have been related to the break in. Records had to be found, entered and reconciled, as it was learned that it was not done as expected by the administrative hire. APEX had only our Executive Director, who experienced multiple health issues from July of 2017 through April of 2018, leaving limited availability to run the program, find and reconcile data, and go to numerous doctor appointments and tests. APEX had no funds to hire additional help. As funding improved and our E.D. was complete with testing and therapies, we were able to reconcile accounts and complete our 990 for 2016, but then had to do the same for 2017 after that was complete. This had to be accomplished with little to no staff due to funding issues and furloughs that began in the fall of 2018. We did receive an extension for our 2017 filing that was for November of 2018. We realize that not having time is not reasonable cause. We are asking for a reduced penalty, factoring the theft, vandalism, and cumulative time missed, funding issues and subsequent furloughs. We now have a new system of cloud backup not just of software, but of hard files to be scanned in case of another vandalism. all previously lost records are now entered and all books, including 2018, are up to date.
