The food pantry program operated 6 food pantries and distributed 2,555,940 pounds of food to the people of Yakima County. 42,599 household food boxes were distributed, feeding 154,609 individuals. These numbers represent 29% of all people in the Yakima County receiving service from a food pantry.

The Camp Hope program reduced street homelessness in Yakima County through daily outreach services, shelter services in 2 locations, housing at 6 sites, and transportation to bring those experiencing homelessness to services.
