Our program service is to provide two meals per day (one hot meal and one cold meal), 5 days per week, to participating clients. We currently have approximately 36 clients. We have two part-time cooks to prepare the meals and approximately 70 volunteers who help prepare and deliver the meals. The space utilized to prepare the meals is donated to us by another charitable organization to whom we make occasional payments to assist with upkeep and maintenance. We charge our clients \$25 per week for 10 meals. These charges plus donations fund the organization.

Enclosed please find the revised tax return for 2019 from Lakeview Area Meals On Wheels. As per the instructions 990EZ Schedule A has been completed and added in with our original submission.

As a reasonable cause as to why it was not submitted originally, I can only say it was an oversight by the volunteer who prepared our return. For several years as our organization had a budget of under \$50,000 we only completed our return by epostcards. As our receipts increased in 2019 we then had to file differently and do a complete return. Due to the difference in filing and not being as familiar with the necessary forms needed Schedule A was not completed. As stated before it was an oversight and will be addressed correctly for our 2020 return.
