Classes are offered at no cost to students, bus passes are provided - making it easy for students to get to and from classes and home. Courses provide opportunities for students to share work with professionals, the community, and the world through exhibits and performances. Art classes provided are Ceramics, Photography, Graphic Design, and Music Recording and Production. Classes are offered in four sessions (Fall, Winter, Spring, and Summer) for eleven (11) weeks. There are 18 seats available in each program. Through these programs, NewBridge is launching careers for unemployed and underemployed individuals within the Greater Cleveland Metropolitan area. NewBridge ensures the most convenient, comfortable and successful learning experience for our students. For example, we provide easy access through a central location in Cleveland's emerging HealthTech corridor and a space that is accessible, safe, and beautiful. Our students also have access to the latest in professional equipment and teachers with decades of career and personal success. NewBridge's small, committed staff works in partnership with other organizations to ensure that our participants receive the support and resources they need to achieve success. For example, NewBridge partners with healthcare industry, our region's largest employer, to connect students to jobs as either hospital nursing assistants, phlebotomists or pharmacy technicians. These are fulltime jobs with good starting pay (over \$27,000), benefits and built-in career ladders. To date over 85% of our adult graduates become employed in their profession within six months of graduation. In summary, NewBridge works every day to transform lives, doing so in a targeted, innovative way that provides tremendous return on every dollar spent.
