Immigration legal assistance also provide information in immigration fraud prevention and collaborating with USCIS in naturalization ceremonies in monthly basis.

Community education 750 families are informed throughout 35 sessions in 10 different communities. Leadership Development: 3 Hispanic committees including Grand Junction, Montrose, and Gunnison, promoting immigrant integration and collaborating with local agencies. Other activities in partnership with agencies include Health Equity Learning Series and Welcoming Colorado events.
