



The CCAC placed an advisor in each of the 13 schools in Jackson County to provide one on one advising for seniors in their college and career planning along with assistance completing college and skilled trade applications, FAFSA and loan applications, and scholarship applications. The Center also assists with federal and direct loan applications including the local John George loan program. The Center also maintains a central location for all Jackson County residents for assistance with the post-secondary process and career preparation including resume and cover letter consulting, interview skills, and job search.

The Kids2College program and Pathways to Professional Skilled Trades are programs for 8th graders to learn about turning their talents into careers. The CCAC worked with students from eight districts this year serving 1237 middle school students. Programs included trips to colleges and/or a visit to a local manufacturing company.
