the return. All board members responded with an approval and the tax paperwork was mailed

documentation to top donors, all churches, and non-profits that contribute to the organization. The annual report includes cash flow,

are provided, how many people received assistance, and organizational needs

Part VII. Robert Hill (President/CEO) handles call and direct assistance. Erwin Lankford (VP/Assistant CEO) handles other assistance as
needed. Paul Porter (Board Member) handles money and other assistance as needed. Emily Cooper (Treasurer/CFO) handles the boxes and
taxes and deals with legal and procedural issues. No person at Greater Works gets paid, everyone is a volunteer. We have a dedicated
volunteer staff that run the Clothing Closet, Food Pantry, Outreach Services, and work with dedicated volunteer groups to provide meals, a
day center, and other services. All of us work full-time (or are retired) and make time for this ministry because we believe in what it stands for
- God's unconditional love - and what it does - help take care of our community members that need a little help
