P-Solutions has a primary goals of helping (1) low-income families become self-sufficient; and (2) small business owner succeed.

During the past fiscal year our Empowerment and Economic Opportunity Program (EEOP) successfully served 49,605 low-income families and individuals needing financial education or job-training. Our EEOP also served 925 small businesses needing financial, accounting, and business management assistance. The organization also facilitated home-buyer education that benefited 1,526 families through partnership and collaboration with HUD certified housing counseling agencies.
Through our collaborations with local Law-Schools, Business-Schools, Colleges, Law Firms, and CalCPA societies, we also:
(1) Assisted 641 businesses with lending, strategic planning, process optimization and reorganization;
(2) Helped 62 persons to sit professional exams and obtained licenses and certifications;
(3) Conducted 1,285 quarter-end accounting, financial reporting and budget projections for qualified small businesses;
(4) Conducted 262 financial needs and technical capacity assessments for community-based nonprofits - helping 42 participants;
(5) Trained 256 low-income veterans and aspiring-entrepreneurs on business plan, entrepreneurship, finance and start-up capital; and
(6) Managed 275 (legal, financial, and management experts) volunteers, who spent over 22,182 hours participating in our EEOP Workshops, Small Business Accounting Seminars, and our Business-Management and Business-Optimization classes.

During the year, Poverty Solutions also Hosted 42 workshops, orientation, and community meetings with faith-based partners and Municipal agencies partners, and on School-Based Outreach platform. Participants from the workshops were mainly low-income families looking to participate in our Empowerment & Economic Opportunity Program Individual Development Accounts (EEOP-IDA). Through the workshops and financial literacy training P-Solutions was able to achieve the following:
(1) conducted 12 financial literacy and entrepreneurship development classes;
(2) trained 225 low-income persons and families on workplace ethics, financial management, budgeting, consumer credit, debt management, homeownership, and economic self-sufficiency;
(3) graduated 226 IDA program participants;
(4) processed 809 calls from low-income families about Earned Income Tax Credit;
(5) provided FREE tax preparation to 326 families low-income families; and
(6) funded 34 entrepreneurs through our microlending component of EEOP-IDA program .
