"Immerse Arkansas" works to assist youth in crisis, including older and former foster youth, in their transition to adulthood through the following supports:

- Community Integration
- Spiritual Guidance
- Mentoring
- Life Skills Training
- Career and Educational Support
- Semi-Supervised and Scattered Site Housing

In 2016 Immerse Arkansas received its own 501(c)(3) exemption under an Arkansas non-profit corporation of the same name. Also in 2016, Village and Village began making grants to this new entity in order to fund and maintain a building that will be used for its future operations. It is expected that by early 2018, all program functions of Immerse Arkansas will have transferred to this new entity.

"The Orchard" serves low-income communities in the 72204 zip code by providing food, clothing, furniture and/or employment opportunities. In 2016, 19,668 individuals were served by The Orchard.

"Fresh2You" is a mobile farmers' market that brings fresh fruit, vegetables, and produce to communities in need, and to seniors with limited mobility, at affordable prices for those on fixed incomes or the Supplemental Nutrition Assistance Program (SNAP). In addition, through a partnership with Cooking Matters (a program of The Arkansas Hunger Relief Alliance), Fresh2You provides nutritional education by providing affordable, healthy recipes. In 2016, 2,054 individuals were served by Fresh2You.

Immerse Arkansas holds custodial funds for certain of the youth it serves. Former foster youth receive a monthly stipend from the Arkansas Department of Children and Family Services. Those funds are paid to Immerse Arkansas monthly and are then distributed to the respective youth bi-monthly. In addition, certain other youth accumulate funds that might eventually be used to obtain their own apartment, a vehicle, to fund their education, or some other purpose. As to Immerse Arkansas: In 2016 Immerse Arkansas received its own 501(c)(3) exemption under an Arkansas non-profit corporation of the same name. Also in 2016, Village and Village began making grants to this new entity in order to fund and maintain a building that will be used for its future operations.

As to The CALL and the Pulaski County Adoption Coalition, Inc.: In 2016 Vine and Village conducted a walk-a-thon known as "The Walk for the Waiting", the results of which are disclosed on Schedule G of this Form 990. In Arkansas in 2016 there were about 1,200 children waiting for a foster family, including 500 that are waiting to find an adoptive family. Because of the shortage of families, nearly 220 children will "age out" of the system this year and enter into adulthood without having found a forever family. The Walk for the Waiting is intended to support waiting children and the families that care for them by using the proceeds to help fund Immerse Arkansas, as well as the CALL and the Pulaski County Adoption - two other local organizations that are very active in this cause.
