BECAUSE OF THE SHORTAGE OF FAMILIES, NEARLY 220 CHILDREN WILL "AGE OUT" OF THE SYSTEM THIS YEAR AND ENTER INTO ADULTHOOD WITHOUT HAVING FOUND A FOREVER FAMILY. THE WALK FOR THE WAITING IS INTENDED TO SUPPORT WAITING CHILDREN AND THE FAMILIES THAT CARE FOR THEM BY USING THE PROCEEDS TO HELP FUND IMMERSE ARKANSAS, AS WELL AS THE CALL AND THE PULASKI COUNTY ADOPTION COALITION - TWO OTHER LOCAL ORGANIZATIONS THAT ARE VERY ACTIVE IN THIS CAUSE.
