BEYOND HUNGER WORKS TO END HUNGER THROUGH DISTRIBUTING FOOD TO THOSE IN IMMEDIATE NEED WHILE WORKING TO EDUCATE THE COMMUNITY ABOUT THE ISSUE AND SUPPORT ANTI-HUNGER POLICIES AND INITIATIVES. IN FISCAL YEAR 2020, BEYOND HUNGER PROVIDED EMERGENCY SUPPLIES OF FOOD THROUGH FOOD PANTRY AND HOME DELIVERY PROGRAMS SERVING 12,584 HOUSEHOLD VISITS (39,630 INDIVIDUALS). IN MARCH 2020, PROGRAMS ADJUSTED IN RESPONSE TO COVID-19 TO MAINTAIN THE SAFETY AND HEALTH OF CLIENTS, VOLUNTEERS, AND STAFF. OUR PRE-MADE FOOD RESCUE PROGRAM WITH LOCAL CAFETERIAS DONATED 10,785 MEALS BEFORE BEING PUT ON HOLD IN MARCH. OUR SUMMER MEALS PROGRAM ASSISTED WITH THE PROVISION OF 218,412 MEALS AND SNACKS TO CHILDREN THROUGH PROGRAMS AT PARTNER AGENCIES IN OAK PARK AND BERWYN. WE CONNECTED 1026 HOUSEHOLDS TO ONGOING INCOME SUPPORTS LIKE SNAP, MEDICARE, AND BENEFITS ACCESS. THROUGH MARCH, THE NUTRITION EDUCATION PROGRAM REACHED 7,393 INDIVIDUALS WITH FOOD DEMONSTRATIONS AND WORKSHOPS.
