To provide a healthy and safe shelter for the homeless and their families. They can rest, shower, and receive clean clothes. They must pass a background check and breathalyzer test, and have their bags searched for inappropriate items such as knives, guns, drugs, or bed bugs. The shelter also encourages positive interactions with other shelter residents and the community. The shelter is open from 6PM to 8AM daily. In extremely hot or cold conditions, the shelter remains open for 24 hours. An Executive Director and shelter aides ensure policies and procedures are properly followed. The shelter operated without an Executive for about eight months during 2018.

The Life Skills program was discontinued in 2018 in favor of individual counseling and training to assist the specific needs of clients.
