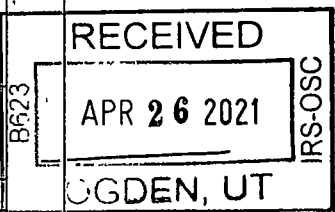



Guests may rest, shower, and receive clean clothes. The shelter also encourages positive interactions with other residents and the
community. The hours are from 6PM until 8AM on a daily basis. In extreme weather conditions, the shelter remains open 24 hours.

The shelter is always staffed by the executive director and shelter aides to ensure policies and procedures are properly followed.
