<p><b>28</b> We put on clinics called "Chicks n Chaps Women's Rodeo Clinic". The attendees learn about the sport of rodeo from top professional cowboys and cowgirls, we have information booths from local hospitals, breast cancer organizations, MRI companies, just to name a few to help educate our attendees. We have local celebrities, doctors, and breast cancer survivors speak to bring breast cancer awareness to the attendees. In the eight clinics that were held in 2018, we have over 500 attendees and over a 100 volunteers. We generate our income from registration fees for the clinics, cash donations and in-kind donations. We solicit these donations through personal contact of our board members and other volunteers. We donate net profits to individuals who need financial help while fighting breast cancer. All board of directors, committee members, cowboys, and cowgirls donate their time. We plan, promote, implement these events to raise money for individuals fighting breast cancer within their communities. We put clinics on in Montana and Arizona. We assist committees in California, Idaho, Texas and Oklahoma to put on clinics to benefit their local breast cancer foundations. Total expense: \$95,775 was given out as grants or donations to individuals. \$22,008 was spent on development projects.
