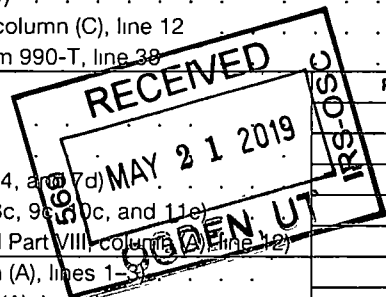

development activities for the preceding year.
