Battle Ground Health care is a clinic providing free medical and dental care in Battle Ground, WA. Nearly all of the services are provided by volunteers, who worked a total of 5,737 hours during 2016. The volunteer hours represent a wide range of medical professionals and support staff and are valued at \$390,819. Visit www.battlegroundhealthcare.org for more information. Summary of patient visits in 2016: Medical, dental, rehabilitation services, vision, chronic pain program visits equaled 823. The three major chronic diseases and diagnosis are hypertension, diabetes, and obesity, the same as what is common nationally. The dental services provide limited dental procedures: extractions, restorations, screenings/X-rays, and hygiene. The total value of these services equaled \$105,321. In November 2016 we started offering rehabilitation services: occupational, physical, speech therapy, medical massage, and chiropractic services. The demand (need) for these services is very high as these speciality services are not accessible or affordable in most cases for the population that we serve. The average cost of a patient visit (which includes all of the services) is \$112. All of the services provided through BGHC are free to the patients. We seek funding through grants, fundraisers, individual donations, and health system collaborative partnership in order to provide these needed services to the community. Free and charitable clinics provide quality care for those who need it most by using volunteer doctors, nurses, as well as all other professionals and individuals who have the gift of caring and compassion to serve others.
