 Battle Ground HealthCare (BGHC) is a non-profit faith based organization that is dedicated to caring for our community. Our mission is to improve the medical, dental, and (physical) rehabilitation health of our community through the reduction of the costs of emergency room visits by managing patients with chronic care needs, and to improve the overall quality of life for those around us. BGHC serves as a medical home model for patients until they qualify for insurance or can find a provider. The care provided includes professional medical and dental diagnosis and treatment, limited prescription services, limited laboratory testing, dietary consultation and guidance, and emergency department referrals for acute exacerbation of chronic conditions needing ongoing care. BGHC serves everyone who enters the clinic. However our focus is the north Clark County individuals between the ages of 18 and 65+ who are uninsured or under-insured with little or no income and whose family income is at or
