Homeless Youth Connection (HYC) provides homeless youth with basic necessities such as, clothing, food, hygiene items, and school supplies, case management, host families if needed, as well as resources for medical care, counseling and tutoring. In addition to basic necessities, HYC provides youth with life skills training and mentoring. HYC serves youth ages 13 to 19 who have been identified as homeless according to McKinney-Vento. HYC partners with 50+ high schools throughout Maricopa County. Since 2010, HYC has served more than 900 youths, ages 13 through 19. Last year, HYC assisted 245 homeless youth. Of those students, 76 were graduating seniors. As a result of the success with the Host Family program, as well as the excellent work of our case management team, HYC has been asked to expand its services to other districts throughout Maricopa County. Beginning in August, HYC will serve 12 school districts which include more than 50 high schools in the East and West Valleys, Phoenix, Glendale and Deer Valley. We are very excited about the opportunity to assist more homeless youth. Recent reports from the Arizona Department of Education indicate that there are more than 4,200 homeless youth attending high school in Arizona, and 529 of those students are unaccompanied youth, or youth on their own. By increasing our reach from six districts to 12, we plan to assist more than 400 homeless youth in the upcoming school year.
