THE WCMG REGISTERED A FICTITIOUS NAME TO D/B/A THE WRIGHT CENTER FOR COMMUNITY HEALTH. WCMG APPLIED AND WAS SUCCESSFULLY DESIGNATED A FQHC LOOK-ALIKE BY HRSA EFFECTIVE JUNE 1, 2019. AS A RESULT, IN APRIL OF 2019, THE GOVERNING BODY OF CHH DETERMINED THAT IT WOULD BE IN THE BEST INTEREST OF THE ORGANIZATION IF IT AMENDED ITS BYLAWS TO EXPAND ITS PURPOSE FROM THE NARROW SPECIFICITY OF BECOMING A FQHC TO FIT WITHIN THE SCOPE OF 501(C)(3) AS A CHARITABLE, SCIENTIFIC AND/OR EDUCATIONAL ORGANIZATION DESIGNED TO "SUPPORT THE IMPROVEMENT OF THE HEALTH AND WELFARE OF OUR COMMUNITIES AND OUR NATION."
